TOO OFTEN THE CHILDREN IN LOW-INCOME APARTMENT COMMUNITIES RETURN FROM SCHOOL TO AN EMPTY HOUSEHOLD WITH NO PARENTAL SUPERVISION BECAUSE THE PARENT(S) ARE WORKING ONE TO THREE JOBS TO SUPPORT THEIR FAMILIES. WE HELP TO ALLEVIATE THE RISK OF BEING ALONE FOR THESE CHILDREN. DAILY ACTIVITIES INCLUDE EXERCISE, A HEALTHY SNACK, AND SCHOOL ASSIGNED HOMEWORK(WITH ASSISTANCE FROM OUR VOLUNTEERS).
